Commodore's Report

One accident of a personal injury has occurred this season, the member was sent to hospital for treatment and released. A review of on board procedures is underway.

An accident to the boat involving lines from the Jacobs Cradle becoming wrapped around the prop required PARU to be pulled from the water and the props replaced with the spares. The damaged props are being repaired. The cost of repairs will be submitted to the CCGA for reimbursement as PARU was on a tasking at the time.

An application for Commercial Registration has been made to Transport Canada subsequent to letter from CCGA noting that it is a requirement. We have received acknowledgement of application waiting for approval or not. A general discussion was held regarding implications to insurance, Marine First Aid, fire suppression

requirements, marine medical should Commercial registration be granted. Colin will investigate.

The 50th Anniversary was a successful event, Colin thanked Bill for ensuring Jennifer O'Connell for attending.

Training has been ongoing this season for Phase 1 and Phase 2, many members have passed and certificates should be issued soon. 2 new coxains were added this season. Some of the established Coxains were grandfathered into the SPOCs but the affected members are taking the training should the exception be pulled.

The Bylaw Committee with continue with the review of the bylaws again over the offseason. The business plan, strategic plan, and SOP's will also be reviewed/updated.
